A greater degree of cervical dilation is required, and suction curettage alone is inadequate. Long, heavy forceps are frequently required, as well as additional time for completion.

This Form has been adopted by the Texas Medical Board in accordance with the requirements of §164.052(c), Texas Occupations Code and is published in 22 Texas Administrative Code §165.6(f). The purpose of this Form is to allow the physician to obtain the required consents for an abortion to be performed on an unemancipated minor.

A miscarriage is the loss of a fetus within the first 20 weeks of pregnancy. A miscarriage may also be called a spontaneous abortion or an early pregnancy loss. DISCHARGE INSTRUCTIONS: Seek care immediately if: You have foul-smelling drainage or pus coming from your vagina. You have heavy vaginal bleeding and soak 1 pad or more in an hour.

But if you have a new vaginal discharge or new or increasing pelvic pain, a pelvic exam may be done while you are having your period. • Do not use douches,
